

Terms & Conditions

1. Introduction

Welcome to Midas. By accessing and using our crypto trading bot services (“Services”), you agree to be bound by these Terms & Conditions (“T&C”). If you do not agree, please do not use our Services.

Midas provides an automated trading solution that connects to third-party trading platforms (such as Binance, KuCoin) via API integration. We do not request, store, or manage your crypto assets. Your funds remain in your own trading account, and Midas only executes trades based on predefined strategies.

2. Acknowledgment of Trading Risks

2.1 No Guarantee of Profit – Trading cryptocurrencies involves substantial risk, including the risk of losing your invested capital. Midas does not guarantee profits and is not responsible for any financial losses incurred while using our Services.

2.2 Market Volatility – The cryptocurrency market is highly volatile. Profitability depends on multiple external factors beyond Midas' control. Users acknowledge that they may experience both profits and losses.

2.3 User Responsibility – You acknowledge and accept that:

All trades executed by the Midas trading bot are based on your own account and API settings. You are solely responsible for managing your account, risk exposure, and any financial outcomes resulting from the use of our Services.

3.2 API Permissions – Users must set appropriate API permissions. Midas does not have access to withdraw or transfer your funds. We recommend users enable trading-only API access and keep their API keys secure.

4. Fees & Commission

4.1 Profit-Based Commission – Midas imposes a 20% commission on every successful profitable trade executed through our trading bot.
